What Is the APR Awards Program?

Our awards program is entering its 25th year of rewarding customers for making purchases at APR Supply Co. Making purchases from participating vendors within the APR Supply Co. Awards Program will earn valuable points which are redeemable for anything that helps our customer build a better business; from tools to truck lettering - if it helps grow and improve business it can be purchased with awards points. Or, use awards points towards one of the APR trips!

Points Explanation

All points should be redeemed by December 15, 2018. Participants begin to redeem points once they reach \$40,000 in sales for the year. If participants have \$40,000 in purchases on the final day of the promotion, unused points will roll over into the next promotional period.

If the minimum \$40,000 in sales not met during the promotional period, points will be lost at year end.

Points only accrue from participating vendors, so keep this list of vendors handy when ordering. Point totals will be emailed quarterly provided we have your current email address. A final fourth quarter statement will be emailed in January of next year.

Eligibility

To qualify, participants must reach \$40,000 in purchases from APR Supply Co. during the promotion period. Points are awarded based upon purchases from the participating vendors listed in this brochure. Only customers whose credit accounts are kept current are eligible for this program.

Redeeming Points

Redemption of points is granted for items that will help participants build their business. They may also be saved and used for the next APR Supply customer trip. To redeem, purchase the item and submit receipts to the designated salesperson for approval and reimbursement. Reimbursement comes in the form of credit on account or a check.

Payment or credit on the customer's standard account is not an approved redemption for this program. APR reserves the right to decline any redemption that does not fit within our guidelines.

Tax Liability

Any liability for federal (or other) income taxes imposed on any awards received from participation in this program will be the responsibility of the recipient of the award. In cases where requests of total redemption is over \$600 in a calendar year's time, a W-9 tax form will be required.
